1. <u>Convene, Roll Call and Introduction of Audience</u>

Mr. Valdez read the meeting script regarding the hybrid meeting protocols. Ms. Nichols convened the meeting at 1:13 p.m. Roll call was taken and a quorum was noted. There was no audience in attendance.

5. <u>Public Comment/Correspondence</u>

a. Offshore Engineering Design and Computer Aided Drafting (CAD) Work Mr. Valdez stated he received an email from a concerned professional engineer, the email was sent anonymously. The individual indicated they are licensed and work for a multi-national consulting firm. The individual's concern was about

projects being outsourced for cheaper and quicker turnaround time. Mr. Valdez then provided a brief summary of what the individual stated in the email which included concerns such as:

"Most multi-national engineering firms are now pursuing this strategy, and I believe that without strong regulatory intervention this "race to the bottom" will likely accelerate in the coming years."

"Once the design is done, it will be handed to a U.S.-based engineer licensed in the state the project is to be constructed in, who will be given a nominal amount of time to review the design and intense pressure from management to sign and seal it. Quality, public safety, and the reputation of the profession will all suffer, and the decline in demand for American engineering labor will drive down industry standards for wages and benefits, thereby exacerbating the current shortage of engineers."

In addition to these concerns mentioned by the anonymous individual, Mr. Valdez informed the Committee the individual also stated:

"The exact nature of those changes will vary by state, (just like the rules governing the practice of engineering do) but might start with consideration of how the definition of the idea of "responsible charge" can be strengthened to preclude the scenario I describe above."

Mr. Tonander stated that engineering designs are one thing, but drafting is another. Drafting is not regulated by the Board, but he suggested that Mr. Valdez ask the Member Board Administrators from the other jurisdictions and see if they also have had any experience with this. Mr. Tonander also noted that he could bring it up at the Zone meetings.

Ms. Nichols and Ms. McNally agreed with Mr. Tonander. Ms. McNally said this item should be addressed to NCEES to see how other national boards are addressing this concern.
