1. Convene, Roll Call and Introduction of Audience

Mr. Valdez read the meeting script regarding the virtual meeting protocols. Ms. McNally convened the meeting at 1:01 p.m. Roll call was taken, and a quorum was noted. Audience introductions were made at this time.

2. Meeting Notification

Mr. Valdez informed the Committee the meeting was noticed on the Board's website and at the Board Office.

3. Approval of Agenda

4. Approval of Minutes

a. Minutes of June 6, 2024

Ms. McNally tabled the meeting minutes of June 6, 2024.

b. Minutes of June 27, 2024

MOTION by Ms. Nichols to approve the meeting minutes of June 27, 2024, as presented, **SECONDED** by Dr. Elaksher,

The motion **PASSED unanimously.**

5. Public Comment/Correspondence

a. Yamada, J. - English Proficiency Certificate

Ms. Gonzales introduced Ms. Yamada's email in which she is requesting if the Board would accept the TOFEL IBT test. She informed the Committee that currently on the Board's website it shows "An applicant with foreign registration or education requesting registration by reciprocity or exam shall show proficiency in the English language. An applicant who is from a non-English speaking country or a country wherein the primary language is other than English must submit a Testing of English as a Foreign Language (TOEFL) certificate with the minimum score of 575 and a TSE certificate." She noted that this question was placed on the Professional Surveyors agenda to get guidance from both the Professional Surveying Committee (PSC) and Professional Engineering Committee (PEC) on how to proceed with the English proficiency requirement. Ms. Gonzales noted that during the PSC discussion, Ms. Maxine McReynolds educated the Committee that the TOEFL does not have the TSE certificate.

Mr. Valdez stated he researched the difference between the TOFEL IBT and ITP tests. He noted that the ITP has two testing levels, with a minimum score, whereas the IBT does not have different testing levels and has no minimum score.

Ms. Dohleman questioned if other states have moved to the IBT test or if they are accepting other tests. Mr. Valdez stated that he did not know but would investigate the matter with the other states and NCEES.

Ms. McNally asked for clarification that if you take the IBT test you automatically pass the test since there is no minimum pass score. Mr. Valdez stated that is what

he believes.

Dr. Elaksher stated that at NMSU the graduate student applicants that take the test are required to have a minimum score of 79 for the IBT or 550 for the ITP test. He further suggested that if the Board offers a minimum score, they may consider NMSU's requirements.

b. Nanos, N. – BICSI Credential Holder for RCDD Being Allowed to Sign and Stamp T-sheets

Mr. Valdez introduced Mr. Nanos request for the New Mexico Building Officials Handbook be updated regarding signing and stamping, permit sets and construction documents as they pertain to Technology or T sheets on architectural plan drawings.

Ms. Dohleman stated that she did research and the question is about the electrical communication systems, and the certification does not require an engineering degree. The degree that it requires is a technician degree and she feels that this would need to be something Constructions Industries Division would need to investigate.

Ms. McNally wanted more information on how this would be considered as an alternative to a PE electrical engineering seal. She asked if this issue has come before the Committee before. Mr. Valdez stated that this was the first time this issue has come up to the Committee. However, there was a similar issue with a NICET certification being considered by some review bodies as an alternative to a PE fire protection engineering seal. The Committee addressed the issue and stated that the certification will not qualify and that they would need to be licensed as an engineer.

Ms. Dohleman stated that this question should be sent to the Construction Industries Division to see if they would accept the BICSI Credential Holder for RCDD.

Dr. Elaksher informed the Committee that after looking at the BICSI website it does not show a specific accreditation. He noted that the Committee should be very careful when considering the BICSI credentials.

Ms. McNally tabled the discussion until further information was received from Mr. Nanos and Constructions Industries.

c. Del Toro, A. – Engineering Intern Certification for Endorsement Applicants Mr. Del Toro informed the Committee that he had applied for licensure as a Professional Engineer through comity. His application was reviewed by Board staff, and he received notification requesting a verification of EI certification. He noted that in Utah, where he received his license, that once they have received their qualifying engineering degree and have passed the NCEES FE exam, they are considered an EI without receiving the official EI certification. Mr. Del Toro requests the Committee to consider the EI certification requirement not being required for licensure by endorsement.

Mr. Valdez notified the Committee how many States require the licensee to have EI certification. There was a total of six states that do not require EI certification, and two states did not answer.

Mr. Del Toro noted that in the other states that he had applied for licensure never requested verification of EI certification.

Ms. Dohleman requested clarification on the process for PE endorsement applications without EI certifications.

Ms. Gonzales informed the Committee that Board staff is currently requesting the endorsement applicants to apply for EI certification by filling out the application form. The fee for the application is waived for PE endorsement applicants. She noted that she had created an affidavit to streamline the process for the Intern Certification for Professional Endorsement applicants, which is on the agenda in Old Business and on the Full Board agenda for consideration.

Mr. Valdez wanted to receive clarification from the Committee regarding the New Mexico Engineering and Surveying Practice Act Section 61-23-14.1 B. (2). The statute reads "an applicant is not certified as an engineer intern and has at least one of the following:" He noted that this is the section that the Committee is using for the bypass of the FE exam. Furthermore, he interprets the statute that if you do not have that EI certification you would only need to meet the requirements listed under 61-23-14.1 B. (2). That the Committee may be able to use that statute for licensure for Mr. Del Toro.

Mr. Del Toro stated his opinion that the PE licensure should superseded EI certification. If the Board is going to require the certification, then he thinks that it would make it more efficient if the Board does not require the application for EI certification.

Mr. Tonander stated that the EI Certification requirement is the law, and the Committee must follow the law. He noted that the Committee has waived the fees and now to make it more efficient staff has created a simplified application.

6. Old Business

a. Intern Certification for Professional Endorsement Applicants

Ms. Gonzales informed the Committee that she created this form because staff was getting a lot of concerns from applicants when staff requested the EI Certification application. To streamline the application the applicants would fill out the form and email it back to the Licensing Administrator. The references and transcripts used from their PE application would be used for the EI certification application.

Mr. Tonander asked if staff could add under the signature line an attestation for applicants certifying that they are not dishonest.

Ms. McNally asked staff to provide the edits for consideration by the Full Board.

b. NM Handbook for Building Officials - Review of Engineering Updates

Mr. Valdez indicated that he had received and incorporated the edits from the Board and the Architects Board. He asked if the Committee could provide him with any additional comments or questions prior to the September JPC meeting.

Ms. McNally asked the Committee to provide Mr. Valdez with any edits by the end of August. She directed Mr. Valdez, that if no comments or questions are received, to send an email reminder to the members.

c. Repeat Offenders Guideline Schedule

Mr. Valdez introduced the Repeat Offenders Guidelines which was drafted up by Mr. Gromatzky. The guideline has been reviewed by the legal enforcement committee and no additional changes were made. He noted that the guideline will be placed at the end of the Fines and Penalties Guidelines Table.

Mr. Tonander commented that the first offense should not be in there since we would be using the Fines and Penalties Guidelines Table. In the other repeat offenses, the first bullet point of each offense which states "If deficiencies in the document or data are found by the Professional Committee, then 100% of the tabulated fines will be assessed to the respondent." of each offense should not be there. The Committee would not be legally able to assess more than 100%.

Ms. McNally agreed that the first bullet point is a bit redundant, and the first bullet can be confusing. She tabled the discussion until the Full Board meeting to receive clarification on their questions from Mr. John Wayne.

d. Recommendations for the Fines and Penalties Guideline Table

Mr. Valdez informed the Committee that the Legal Enforcement Committee had edits and questions for the Board regarding the Fines and Penalties Guideline Table.

Ms. McNally stated that the section that states "offer and perform consulting engineering services", should be clarified to what offering means. She also noted that in the section includes redundancy in the violation of offering and performing consulting engineering services. The table would need to be cleaned up and clarified before the Full Board approves.

Mr. Tonander suggested that there be a small Committee to help with the cleanup of the table. Ms. Dohleman stated that Mr. Robert Gromatzky and Mr. John Wayne should be within that Committee.

7. New Business

a. Advisory Opinion: Expert Witness Testimony

Mr. Tonander stated that he created the Advisory Opinion because this is an issue that keeps coming up. He wanted to advise individuals that expert witness testimony is not under our jurisdiction but rather the domain of the courts. However, he wanted to advise the expert witness to when the Board would have jurisdiction.

Mr. Valdez informed the Committee that Ms. Hovie needs to review the Advisory Opinion, and it will be placed on the November meeting Full Board agenda.
